## A DREAM COME TRUE!

When we opened the Habitat ReStore at 620 Wilson Street in 2005, we didn't expect that location to be permanent. Even so, we were excited to get things up and running, and knew we had plenty of time to locate another building before the store's lease expired in December of 2012. The business grew quickly as the years passed, and we started thinking about where we wanted to be. Early on, the property at 1123 Central Parkway was attractive, but the cost of the building was beyond our reach. One of our employees sent up frequent prayers asking God to make a way for us to acquire the building, if He so willed. At one point, we submitted a bid for less than half the asking price. Our offer was rejected. But the hopeful group from Habitat began a savings plan to secure a building sometime in the future.



Fast-forward to the July 2011 Strategic Planning Session for Habitat. Participants set a clear plan for the future. Goal #3: Secure a new ReStore and office facility by June 30, 2012. A Search Committee was selected, and the next 9 months were spent finding a building we could afford, in an excellent location that would meet the needs of our ReStore, Construction & Administrative departments. Guess where it was located? Yep, 1123 Central Parkway! Our savings had gone up, and the price had come down. Our prayers were answered!

Are we more excited, or the customers? I'm not sure, but there ARE going to be a number of perks at the new location that we'll all enjoy. Here are just a few:

- Better climate control. Many of you know that the ReStore has sometimes had to close on summer or winter days when the temperature wasn't exactly conducive to shopping. Our new store has insulation, heating, and cooling.
- More parking spaces. Currently, customers are often forced to park at other businesses or in the alley across the street. Soon, this will no
  longer be an issue, as we have over 40 parking spots at our new location.
- More space and better layout. We will add about 3000 more square feet of space across 2 large warehouses, rather than being chopped up into multiple rooms as we are now.
- Designated drop-off area. When donors visit the store now, they are dropping off in the same area where pickups are occurring. These "traffic jams" will soon become a thing of the past.
- Larger restrooms. You may not think this is important until you need to go, and the WC is already occupied. The new store has numerous restroom facilities, and they are easily handicap accessible.

We'll be opening this fall, and we can't wait to show off our new digs!

### Family Spotlight: The Burt Family

It was dark. She was 16, pregnant, jobless...and alone. With nowhere left to turn, she realized she would have to spend the night in her car. In the silent, lonely hours that ensued, she wondered how she would survive. But she did.



Fortunately, it wasn't always like this. Felicia actually grew up in a Habitat house. Her face lights up when she recalls moving into the house shortly before

Christmas in 1993. She was 4 years old. They had moved from the projects. She was the youngest of four children. They all loved their new house and especially enjoyed having a yard to play in.

The day Felicia turned 18, she went out and got a job. She was determined to be on her own and make a life for herself and her daughter. The company she worked for was sold a few months later, and paychecks began to bounce. A few weeks later, the plant doors closed completely, leaving employees without a paycheck right before Thanksgiving. Fortunately, Felicia's mother suggested she apply for a job at Wayne Farms. She was quickly hired on and has been there ever since.

In 2010, Felicia applied to Habitat. She was on break at work when she got the call that she'd been approved for the program. She went crazy, screaming and dancing in delight at the news. Her coworkers kept asking, "What happened?!" She finally recovered sufficiently to share the good news.

Since then, Felicia has been hard at work attending classes, learning the fine art of budgeting, and developing construction skills, besides working each day and raising two little girls. When asked what she'd enjoyed during the course of her Habitat experience, she responded with a smile, "Putting up walls!" She said seeing all the pieces that make up a house is valuable, as are the relationships you build in the process. She said that at times, the expectations of the Habitat program can be tough, but "you have to go for what you want, even when you don't feel like it."

What's her encouragement to potential sponsors and volunteers? "Don't do it out of obligation; let it come from your heart. Look into the eyes of Habitat families and feel their pain." Some of them (like Felicia) have lived in that place where they feel they have nowhere to turn and nobody cares. "If you can help, do. It will be a blessing to you and to the family you help."

Meanwhile, Felicia, her daughters, and Missy (the dog) are waiting patiently for their blessing to roll around. Will you help to make it happen?
